He plans to refinish the exterior to bring back the look from the 1930's. The plan is to use the building for a retail store. The tanks and any contaminated dirt will be removed and filled with good dirt. The City of Cavalier has approved a \$4,000 storefront and energy efficient improvement grant.

Benjaminson motioned to approved a \$5,000 storefront improvement grant, seconded by Monson; motion carried.

Hartz Holding, LLC

Dave Hartz is requesting a \$5,000 Storefront Improvement grant for the thrift store in Cavalier which is switching locations. This is in the old True Value Building. He would like to put in new windows and siding. The City of Cavalier has also approved a storefront improvement grant.

Monson moved to approve a \$5,000 storefront improvement grant, seconded by Kemnitz; motion

carried.

OTHER BUSINESS

Melissa Gapp is no longer the city auditor for the City of Walhalla. She will be replacing the Pembina County Auditor.

The Pembina County jail has closed. There needs to always be two jailers on duty and they are unable to find employees.
