MEETING PREFERENCE FOR 2023

Meeting preference was discussed for 2023 whether the meeting should be held in person, hybrid or virtually. Holding hybrid meetings can be difficult with technology in some areas and hard to do presentations or tour of businesses. It was decided to take one meeting at a time as to which way the meeting would be held.

The meeting day will be changed to the second Tuesday of every other month as a day that is better for members, it will be easier for in-person meetings.

JDA DIRECTOR POSITION RECOMMENDATION

The interview committee consisted of Hinkle, Stremick and Mandt. There were three high quality applicants. Angelle French, a resident of rural Hamilton, is the committee's recommended candidate for director. She is currently the director of the Walsh County JDA. French will start with the Pembina County JDA on February 21, 2023.

It was recommended the starting salary be \$55,000. Currently, French's salary is higher than what was offered. French will be a RRRC employee which has an annual contract with Pembina County of \$150,000. The authority has much discussion on the beginning salary for French.

Nordstrom approved a starting salary of \$60,000 with a six-month review; annual reviews after the six-month introductory period and 10% retirement contribution in six months, seconded by Stremick; motion carried.

An update will be given at the March meeting as to the office location for the JDA director.

RURAL DEVELOPMENT TESTIMONY OPPORTUNITY

Mandt and Matt Marshall, Minnkota Power, testified at the Senate and Housing Ag Committee regarding rural development concerns and how rural communities are impacted by agriculture.

OTHER BUSINESS

Houdek shared Job Service is hosting a nation-wide virtual job fair on February 8.
